## **I. General information about the organization:**

In 50s of the XX century appeared the question of possession of the products. By 1953 Brest shops were using four cooling installations for the production of ice and the safety of the products.

On 18 February 1965 on the base SMU-4 are made workshops of the plant "Belgostroy". The number of employees - 16 persons. Activity – repair and maintenance of trading-technological and refrigerating equipment for trade enterprises of the Brest region.

To increase efficiency of using, to improve the quality of services on 9 May 1967 order this organization was re-named into Brest Regional Unite of Repair and Assembly “Beltorgmontazh”.

The development of the state trade caused a need in refrigeratory and technologically efficient appliances, cash registers. The Minister of the trade BSSR re-named Brest Regional Unite of Repair and Assembly “Beltorgmontazh” into Brest Regional Branch of the Unite “Beltorgtehnika” №5 with operational command of the local trade controlling.

In 1983 was opened manufacturing base in Pinsk, in 1985 – in Baranovichi.

In 1998 this organization was re-named into Brest Regional Unite of State Manufacturing Community by order of Trade Ministry of BSSR.

In 2000, this company was known as State Manufacturing Unitary Enterprise “Bresttorgtehnika”.

Since 2013, the company became known as Open Joint Storck Company “Bresttorgtehnika”

***The main activity:***

- editing, commissioning, maintenance and repair of trade and technological and refrigeration equipment, maintenance and repair of cash summing-up registers, scales, weighing systems and electronic automotive equipment (88,25%).

*Other activities of the company:*

- trade commercial-technology and refrigerating equipment, cash summing devices, scales, weighing systems, taximeters;

- provision of services by the laboratory of electrical measurements (measurement and testing of parameters of electrical installations, certification of ventilation systems, measurement of illuminance, microclimate and noise levels at workplaces, in industrial and public buildings)

- production of neutral equipment from stainless steel and black metal for kitchens (tables, shelves, washing bath, cabinets, stand equipment and other equipment from metal in the design of the customer);

- collection and primary processing of scrap equipment containing precious metals with the subsequent delivery of scrap for recycling;
